Crossing under county Road(s) Rules & Regulations

All Roads:

- 1. Petition requesting authorization to cross county road(s) must be filed with the Dawes County Board of Commissioners.
- 2. All future installations must be at least seventy-two (72) inches below crown grade or sixty (60) inches below ditch grade.
- 3. All future installations will be slip lined (i.e. small pipe or cable inside Larger pipe) for a distance of at least thirty-five (35) feet each side of center of roadway.
- 4. Owner of the line assumes all responsibility for installation and maintenance.
- 5. Dawes County will be notified upon completion of placement so that line can be entered on GPS system.
- 6. All future lines must have a capped 2" PVC marker identifying the type of line and the owner's name.
- 7. The Order, when signed, will be filed with the Dawes County Clerk.

Graveled Roads:

- 1. No graveled road surface shall be cut-crossing under road must be bored.
- 2. Boring must begin at least twenty (20) feet from the shoulder of the road and end the same distance from the opposite shoulder.

Non-graveled Roads:

- 1. Non-graveled roads may be bored or trenched.
- 2. All trenching in County easement must be compacted to pre-existing conditions.

Telephone Lines:

1. All telephone lines will be buried three (3) feet below crown of road, centrally located or off County right of way.



All crossings of any graveled roadway(s) shall be bored and the surface of such roadway(s) shall not be cut at any time. In the event that the Petitioner removes said line(s) from said roadway(s), Petitioner will replace and recondition said roadway(s) in substantially the same condition as before the removal thereof. All liability of Petitioner for the maintenance and recondition of said roadway(s), after such removal shall cease after approval thereof by the County Road Supervisor; the County shall in no event be liable for damage to any of the Petitioner's property located within the county right-of-way; provided, further that the construction or laying of said line(s) by Petitioner herein under this order shall be considered and shall constitute the acceptance of this order and all of the terms and conditions herein set forth. Petitioner shall give notice to the County Commissioners of all intended installation or removal in writing at lest ten (10) days prior to the next regularly scheduled Commissioner's meeting before undertaking any installation or removal work contemplated by this agreement.
