### DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners meeting in regular session was commenced at the hour of 8:04 A.M. on the 21<sup>st</sup> day of January 2009 in the Dawes County Commissioners Room pursuant to public notice as required by law. The meeting was called to order by Commissioner Blausey. Roll was called and the following Commissioners were present: Commissioners' Blausey, Wess and Johnson. Also present was Cheryl Feist, Dawes County Clerk and Megan Failla. Per LB 898 the Chairman announced the location of posted information concerning the Open Meetings Act located in the Commissioner Room. Copies of the Act are available upon request by anyone attending the meeting. Commissioner Wess asked his phone number be published so individuals having questions concerning Commissioner District 2 could contact him. That phone number is (308) 430-3953. Motion by Wess, seconded by Johnson, approving the Agenda as submitted. Roll call vote, Ayes: Wess, Johnson and Blausey. Nays: None. Motion carried. Minutes of the January 07, 2009 Commissioner Meeting were reviewed by the Board. Motion by Wess, seconded by Johnson, approving the minutes as published. Roll call vote, Ayes: Johnson, Blausey and Wess. Nays: None. Motion carried. Claims were reviewed. Motion by Johnson, seconded by Wess, approving all claims as submitted. Roll call vote, Ayes: Blausey, Wess and Johnson. Nays: None. Motion carried. Correspondences received were: SWANN re: Board meeting minutes; NIRMA re: Qrtly Loss Report and introduction of Tim Baxter as the new Law Enforcement and Safety Specialist for NIRMA. In other business a motion was made by Commissioner Johnson, seconded by Wess, to surplus fifty-two (52) voting booths, eleven (11) top load ballot boxes and one (1) eight (8) pane 281/4x561/2 glass window. Roll call vote, Ayes: Wess, Johnson and Blausey. Nays: None. Motion carried. Commissioner Johnson reported he wouldn't be able to attend the Area Aging Board meeting as he will be in Kearney at a County Board Workshop. No one appeared for Public Comment.

At 8:53 A.M. Harvey Keim, Highway Superintendent, met with the Board. He presented the One and Six Year Road report to the Board and announced a public hearing has been set for February 04, 2009 at 9:30 A.M. in the Commissioner room to hear input, suggestions or concerns relevant to the One and Six Year Road report. A copy of the report is available for public inspection during normal business hours in the Clerk's Office. He informed the Board blading continues on county roads and trailer repairs are being done. Kerri Rempp, Chadron Record, joined the meeting in progress at 9:01 A.M. The Board discussed a letter received from Sheriff Karl Dailey re: salaries of the Sheriff's Department Employees. No action was taken. Commissioner Johnson moved Chief Deputies of Elected Officials will receive pay increases in January of each year when Elected Officials receive their pay increases. The motion was seconded by Commissioner Wess. Roll was called, Ayes: Johnson, Blausey and Wess. Nays: None. Motion carried. A certificate of appreciation was presented to Megan Failla for the work/research Ms. Failla did for Dawes County. The Board thanked Ms. Failla for a fantastic job. Ms. Failla thanked the Board for the opportunity. Ms. Failla reported all TERC cases have been turned over to Russ Hartford. Ms. Failla left the meeting in progress. Daryl Reiger did not show for his scheduled appointment so a motion was made by Commissioner Johnson, seconded by

Wess, to enter executive session at 9:40 A.M. to discuss personnel matters with Lindy Coleman, Assessor. Roll call vote, Ayes: Blausey, Wess and Johnson. Nays: None. Motion carried. Motion by Wess, seconded by Johnson, reconvening to regular session at 10:08 A.M. Roll call vote, Ayes: Wess, Johnson and Blausey. Nays: None. Motion carried. No action was taken.

At 10:09 A.M. Roger Eaton and Phyllis Eitemiller, Dawes County Fair Board, met with the Board. Phyllis Eitemiller clarified they are actually an Agricultural Society per Nebraska Statutes. She went on to say board members are hard to find and retain. Many board members donate their own resources and time. Donations are received locally. Roger Eaton reported there are no gate fees to events allowing everyone the opportunity to participate in activities sponsored by the Fair Board. No liquor sales are allowed during events due to Insurance costs. Commissioner Blausey will put two individuals from the College in contact with the Fair Board to discuss the possibility of Chadron State College events being held at the Fairgrounds. Becky Paulsen joined the meeting in progress at 10:20 A.M. Fair Board meetings are conducted the first Tuesday of each month beginning at 7:00 P.M. in the 4-H building. Janell Rothleutner, KCSR radio, joined the meeting in progress at 10:26 A.M.

At 10:29 A.M. Becky Paulsen, Weed Superintendent, presented her annual Noxious Weed Control report to the Board. Discussion ensued. Commissioner Wess suggested data be referenced in the report. He also suggested display of materials be done at places such as Henkens Implement and like businesses in addition to the Courthouse. Time spent on the Noxious Weed program verses Zoning was also discussed. More emphasis will be placed in the Crawford area due to Scotch Thistle problems. Motion by Johnson, seconded by Wess, directing the Chairman of the Board to sign the report with the suggested changes being made. Roll call vote, Ayes: Johnson, Blausey and Wess. Nays: None. Motion carried.

At 11:05 A.M. Dave Coe and Eric Fuller met with the Board. Also present was Roland Sayer. Mr. Coe presented change order #4 re: change order proposal #'s 12 & 13 which were approved by the Board in the amount of \$2,362.00 at a previous meeting. Commissioner Blausey signed the change order. Mr. Coe reported change proposal #14 re: shunt trip monitoring will be required per the State Elevator Inspector at an additional cost of \$394.75. Motion by Wess, seconded by Johnson, approving change order proposal #14 in the amount of \$394.75. Roll call vote, Ayes: Blausey, Wess and Johnson. Nays: None. Motion carried. Change order proposal #16 re: adding mail slot to door 303 per State Fire Marshall at a cost of \$271.00 was presented by Mr. Coe. Motion by Johnson, seconded by Wess, approving change order proposal #16 in the amount of \$271.00. Roll call vote, Ayes: Wess, Johnson and Blausey. Nays: None. Mr. Coe reported brick work should be completed by January 22, 2009 and elevator shaft windows will be installed today. Eric Fuller expressed concern with elevator access after hours. He informed the Board it will be more cost effective to have the software for the elevator programmed for after hour's access prior to the elevator being installed. If the Elevator Company has to come back and reprogram the software for after hours access it will be very costly. Mr. Coe was instructed to draft a plan for elevator access after hours and visit with the Sheriff to see what will be the best approach for after hour's usage.

At 11:47 A.M there being no further business to address Commissioner Wess made a motion to adjourn the meeting, seconded by Commissioner Johnson. Roll call vote: Ayes: Johnson, Wess and Blausey. Nays: None. Motion carried. The next regular meeting of the Board

will be February 04, 2009 beginning at 8:00 A.M. with a Board of Equalization Meeting, followed by the Commissioner Meeting at approximately 8:20 A.M. A current Agenda to the BOE/Commissioners proceedings is kept on file in the County Clerks office during normal business hours for inspection, but the Agenda will close by 4:00 P.M. on the Friday preceding the Board meeting(s) on Wednesday. The Agenda may be modified to include items of emergency nature.
