## CHADRON, NEBRASKA March 22, 2016 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session was commenced at the hour of 9:00 A.M. on the 22<sup>nd</sup> day of March, 2016 and published pursuant to public notice as required by law. The meeting was called to order by Commissioner Stewart. Roll was called and the following Commissioners were present: Commissioners Stewart, Johnson and Rivera. Also present were Cheryl Feist, County Clerk; Mark Betson; Wayne Fisher; Jerry Schumacher; Mike and Diana Lecher and Cactus Shumway .The Pledge of Allegiance was recited by those present. Per LB 898 the Chairman announced the location of posted information concerning the Open Meetings Act. Copies of the Act are available upon request by anyone attending the meeting. Adam Edmund, Deputy County Attorney, joined the meeting. Motion by Commissioner Johnson, seconded by Rivera, adding the quarterly jail inspection and adoption of Resolution No. 2016-14, (transfer of funds to Weed Department) to the Agenda. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Commissioner Johnson moved to approve the March 08, 2016 minutes as published. Commissioner Rivera seconded the motion. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. Claims were reviewed by all Board Members. Commissioner Johnson moved to approve all claims as submitted with exception of claim #16030239 payable to River A Holdings for a total amount of \$210.45. Commissioner Rivera seconded the motion. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. Commissioner Johnson, seconded by Stewart, moved to pay claim #16030239 payable to River A Holdings in the amount of \$210.45. Roll call vote, Ayes: Johnson and Stewart with Rivera abstaining from the vote, Nays: None, Motion carried, Kristina Harter, Tourism Director and Lindy Coleman, Assessor joined the meeting. Public comment ensued with Jerry Schumacher expressing concern the Board of Commissioner's didn't authorize Commissioner Johnson to meet with City Council Members, John Coates and John Gamby regarding the Airport Zoning Board. Any agreements made at the meeting aren't binding according to Schumacher. Commissioner Johnson reported the meeting was simply discussion and no formal decisions were made. Mr. Schumacher reported prior to exiting the meeting on March 08, 2016 he had suggested Commissioner Rivera meet with the City Council as the Airport is located in his Commissioner District. The County Clerk didn't hear the comment made by Mr. Schumacher for the minutes. Board reports ensued with Commissioner Johnson reporting he did meet informally with City Council Members, John Coates and John Gamby on March 15, 2016. He indicated the City is concerned about the airport and the 500' area. He went on to say the City wants to retain jurisdiction over the cone located in the two (2) mile buffer zone. It was suggested that possibly the Joint Airport Zoning Board report to the City of Chadron and Dawes County Commissioners. Relinquishment of power given to the City Manager in 1980 was also discussed but no action taken. Lindy Coleman, Assessor, reported the scope of responsibility will change from what was originally adopted in the 1956 resolution establishing the Joint Airport Zoning Board. Jerry Schumacher reported doing so would be a violation of State Laws. Mr. Johnson also reported the Area Aging Board met and budget/meals are doing ok, however; there is an issue with background checks. He also reported the Office of Human Development is picking up new clients. Commissioner Rivera reported Region 1 and Panhandle Mental Health will soon have two administrators for the programs, instead of one.

At 9:20 A.M. Janice German, DCAT and Larry Hankin, Highway Superintendent, met with the Board. Discussion ensued regarding County Road No. 50 located south of Buttermilk Road which was opened April 23, 1887 in Road Book A at page 17. The records also show the road is open a ¼ mile to the house. Mike Lecher and Cactus Shumway showed Board members where their land starts/ends. Kerri Rempp, The Chadron Record, joined the meeting. Cactus Shumway discussed access issues with his land. Mike Lecher reported he hired Phil Curd to locate section stake and the section line runs west to the edge of the road. Adam Edmund, Deputy County Attorney, assured those present on behalf of Road No. 50, he would contact the individuals concerned and share this information. Ms. German also reported the road located in Sections 30/31, Township 33, Range 49 was opened per Commissioner Record C, page 404 and named Road No. 1. A resolution was later adopted in 1990 vacating the road, however; the road has always been treated as an open road according to German. Mr. Hankin presented Road Updates to wit:

Districts blading and pulling shoulders. District 1 has two miles of Kudrna Road graveled; District 3 removed and replaced two culverts on Haynes Road and the Crusher is finishing up at the Furman pit and will move to Antelope Road east of Kay's. The Bethel Bridge project has abutments installed, stringers going in this week and the deck is being worked on. He reported crew members will go to ten (10) hour days, Monday through Thursday, beginning April 04, 2016. Crew members will also attend blade school in Scottsbluff on April 05, 2016. Three (3) temporary/seasonal employees will be hired to work in the Roads Department. Commissioner Rivera expressed concern with Graders leaving the windrow on River Road which in turn widens the Road. Discussion ensued. Commissioner Rivera suggested more than the minimum three (3) passes be made by Graders.

At 10:20 A.M. Rachel Johnson, NCAP, met with the Board. She presented information relevant to the RSVP/Foster Grandparents programs. The goal of both programs being to engage the services of older citizens in the community. She reported 308 Volunteers gave a total of 46,000 hours to both programs which calculates to approximately \$949.000.00. Some accomplishments made by the programs include helping to raise \$15,400.00 for the Salvation Army; \$1425.00 raised for box tops for schools; served 550 meals at Closer to Home; 94 children helped 1 on 1 through Foster Grandparents Program; delivered 5,200 meals for meals on wheels, assisted with the mobile food pantry, collected 200 units of blood and provided volunteers at the Post Playhouse. The Board recessed at 10:25 A.M. and reconvened to regular session at 10:35 A.M.

At 10:36 A.M. Tony Serbousek, Communications Director and Chief Lordino, Chadron Police Department, met with the Board. Chief Lordino informed the Board the Viper 911 phone system needs servers and computers replaced to implement text 911 capabilities. Tony Serbousek went over costs associated with the project. Original quotes came in at \$140,000.00, however; Centurylink post dated the maintenance agreement so costs should be less. He reported vendor support will also be necessary at a cost of \$8400.00 annually. He informed the Board a grant has been applied for through Homeland Security to cover a portion of the costs. The remaining costs will come from the E-911 Fund. Chief Lordino shared pictures of the communications equipment and reported the generator project is almost completed. The tower on Table Road was also discussed. Several pictures showing the condition of the building and surrounding area were shared with the Board. Estimated repairs come in at \$14,000.00.

At 11:06 A.M. Kristina Harter, Tourism Director, and Justin Haag, Travel Board President, met with the Board. Ms. Harter went over the agreement between Dawes County and Sioux County. The agreement will allow sharing the services of the Tourism Director in promoting Northwestern Nebraska. Commissioner Rivera, seconded by Johnson, moved to accept the terms of the agreement as presented and directed the Chairman to sign the agreement. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. Commissioner Johnson introduced Resolution No. 2016-14 transferring a \$7,775.00 grant to the Weed Department and authorizing the expenditure thereof. Commissioner Rivera seconded the motion. Roll was called, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried.

At 11:12 A.M. A motion to enter executive session for a performance appraisal was made by Commissioner Johnson, seconded by Rivera. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Commissioner Johnson moved to reconvene to regular session at 11:30 A.M. Commissioner Rivera seconded the motion. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. No action was taken during executive session. The Board conducted the quarterly jail inspection.

There being no further business before the Board, the Chairman adjourned the meeting at 12:10 P.M. The next meeting of the Dawes County Commissioners will be April 12, 2016 beginning at 9:00 A.M. with a Board of Equalization Meeting, followed by the Commissioner Meeting at approximately 9:20 A.M. Both meetings will be held in the former County Courtroom at the Courthouse. A current agenda is available at the Clerk's Office during normal business hours but will close at 12:00 P.M., April 07, 2016.
